Tolerance is what is "legitimate" or "necessary" in this non-law. The legal order is not one which can tolerate a diversity of opinion. That is, a law which tolerates diversity in matters of opinion cannot be the law. It is not a legal order in which you get to choose your opinions to suit your preferences. This legal order is not an order in which you can play favorites. The law is not a law if you can pick out which opinions are morally respectable and which ones you don't like. The law cannot tolerate diversity of any sort, because the law is the law and the law is a necessary part of the legitimate order. To tolerate diversity of opinion, the law would have to change its nature. ... But I do not wish to repeat the same thing a third time.... My position is simply that it is not the business of the law to solve moral problems. It is not the business of the law to persecute people who are in moral error. It is not the business of the law to protect, or of the state to support, a certain type of morality over another... It

cannot be the business of the law to make the morality of societies conform to its own standards. The reason is that there can be no morality without a law. There can be no law without morality.
